Issue Summary:

- Brevard County is thriving with Sustainability Organizations trying to change the culture within the County. Each group has individual focuses and objectives on how to achieve "sustainability."
- Opportune timing for facilitated group decision-making to prevent possible power struggle between stakeholders going forward.
- The Brevard County Sustainability Working Group (SWG) was chosen to serve as a procedural vehicle to organize passionate organizations to create a strong, collective force for change in the community through collaborative priority-setting and collective goals.
- Additional benefits of the SWG will be:
 - Allow stakeholders across interests to come together to decide if they want to be a working group;
 - Streamline communication between organizations;
 - Allow ideas to be shared;
 - Provide opportunities for partnership; and
 - Create a resource for sustainability information within the community.

Outcome:

- The group decided they would like to form a Brevard County Sustainability Group!
- Objectives decided upon by the group:
 - Building partnerships

- Identifying recourses
- Resource for municipal sustainability boards
- Scaling up efforts
- Advocacy (political, education, etc.)
- Bridging gaps
- Sharing successes
- Value of sustainability (lens to view these)



Outcome:

- Brevard UF/IFAS Extension volunteered to host next meeting, become the point of contact, and repository of info for the group.
- Next meeting:
 - UF/IFAS Ext. will send out doodle poll for group to decide date.
 - Group decided one month out for next meeting and can adjust frequency in the future.
 - Pick recurring day of the month rather than doodle polls going forward.



Outcome:

• In future, stakeholders will rotate hosting meetings:

Will offer behind-the-scenes tours which will aid in advocacy.

- Next meeting agenda:
 - Discuss organization list and the resources each provide
 - Mission statement and what additional documents needed.
 - Address who is missing from the group and invite them to future meetings.



Lessons Learned:

- Pre-meetings very helpful:
 - Gathered information and figured out dynamics between stakeholders.
 - Gained understanding of goals of stakeholders which aided in guiding discussions.
- Pre-work is time consuming to do a good job:
 - Over 40 combined hours over 5 months were spent in pre-work which included planning calls; drafting, reviewing, and revising the Process Agenda; determining supplies; setting up the invitation and doodle poll; and actual set up of the meeting room.

• Aha moment:

• It is not the role of the facilitator to solve the groups' problems. It is the role of the facilitator to assist the group in working through the problems by assisting with group dialogue and group interactions.



Lessons Learned:

- While technology goes a long way to assist in coordination of meetings, don't become overly reliant upon it.
 - Links did not show up for everyone.
 - Some stakeholders were annoyed by the e-invite versus an email, whereas others liked the e-invite.
- While deciding not to share the Process Agenda in advance with the stakeholders caused some frustration, it likely resulted in more attendance.

Lessons Learned:

• The highlights:

- The group chose to continue to meet and a volunteer host emerged without any prompting!
- The tools and techniques really work if you just stick with it and are able to adapt in the moment. (icebreaker and ditching break)
- We were asked to facilitate future meetings.
- Alumna expertise was incredibly helpful.
- The hiccups:
 - Recognizing who is in the audience. The facilitator is supposed to be neutral so be careful not to unintentionally isolate any stakeholder.
 - Group Norms may have been better on the Process Agenda after the goals and objectives brainstorm.
 - The #1 misconception about communication is that it has occurred.

Next Steps:

 - Contact list
- Amy creating a Google Drive folder for the group
 - List of current people/organizations and the resources each provide

- Define sustainability
 - Share on Google Docs; everyone will add their organizations definition
