
CARES' MISSION

The mission of the CARES program is to :

- Increase enrollment in the FDACS' Best Management Practices (BMPs) Program,
- Increase public awareness of agriculture's role in protecting and preserving Florida's natural resources,
- And to recognize and honor agricultural producers for implementing environmentally sound BMPs on their operations.



BACKGROUND OF BMPS



- BMPs are written by Office of Agricultural Water Policy (OAWP) and are adopted by rule
- BMPs are written based on research conducted by UF/IFAS and approved by industry
- BMPs address water quality and quantity issues
- Over 3 million acres are enrolled in the program




HISTORY OF CARES


- CARES began in 2001 in the Suwannee River Basin
- Over 550 producers have been recognized statewide
- Florida Farm Bureau Federation (FFBF) strives to have CARES signs from Homestead to Pensacola
- Tried to emulate the Suwannee CARES in other areas, but never caught on

INVOLVING THE COUNTY FARM BUREAUS

- Multi-county meeting to discuss the idea and to gain their input and thoughts
- Collaborating with the County Farm Bureaus (CFBs) to accomplish the mission of the program
- Tying the CARES program into an existing county event
- Will have multiple benefits for the CFBs





OUTCOME FROM THE STAKEHOLDER MEETING

- Over 20 participants representing 10 county Farm Bureaus
- Counties understand and realize the benefits of hosting the CARES program within their counties
- We were able to gain complete buy-in from the participated counties
- Able to use NRLI concepts to facilitate the meetings





MOVING CARES FORWARD

- FFBF will partner with county Farm Bureaus to recognize FDACS approved farmers beginning in the fall of 2013 at county Farm Bureau events
